- **Rubbish of the day generated by the stall, must be taken away on a daily basis.**

- The Cederbergfees Committee accpets no responsibility for products that do not sell and no guarantees can be given in this regard.
- The Cederbergfees Committee extends no guarantee that applicants, if successful, will be placed on the same site as previous years. Successful applicants undertake to accept that they will be satisfied with stall placement as decided by the Cederbergfees Committee.
- Stallholders are to be present on both trading days. If not, they will not be considered for participation again.
- Stallholders who leave early are not entitled to any refunds and will not be considered for participation again.
- There is no waiting list for unsuccessful applicants.
